- The ATC entries (FXF/FXQ/FXO/FXE) can be used to re-issue E-Tickets on a wide range of carriers that file the Fare Penalty via ATPCO CAT 16, above the NOTE section in Fare Rules (FQN).
- The ATC entries automatically generate the applicable Penalty Fee (only single tax code) into the TST, as a Tax Code/Q Surcharge/Additional Amount/Service Element for EMD etc. based on each participating local Airline Policy.
