

Fare Rule Enhancement – Display of the Voluntary Changes Conditions (Category 31)

We are pleased to share the enhancement in the Fare Rules display, wherein, Voluntary changes conditions (FQNx//VC) content will be displayed in fare rules.

Overview:

Many Airlines participate in Amadeus Ticket Changer by sharing reissue conditions filed in Voluntary Changes (Category 31) and identified by the Voluntary Change (VC) category in Amadeus fare notes.

Refer to **FQNATC/CXR**, to get the list of Airlines participate in VC content.

All fares with the **VC. Voluntary Changes category** attached in the fare rule qualify for Amadeus Ticket Changer.

To verify, if a fare rule contains the Voluntary Changes category, enter **FQNxx*VC** (xx to be replaced by the FQD line number of the fare rule you want to display) in the distribution system.

Key features:

- The new feature provides ATC users with the ability to display the airline’s Voluntary Changes conditions applicable to the ticket being exchanged.
