No more difficulty in reissuing E-Tickets without Record Locator of the Validating Carrier!!

Dear Travel Partner,

In line with IATA Resolution 722g, Amadeus is pleased to announce the Enhancement to the Validating Carrier Check on the record locator at Exchange/Reissue time, when the validating carrier does not participate in the new itinerary.

Accordingly, it is no longer mandatory to have the active Segment/Record Locator of the Validating Carrier in the Itinerary while reissuing an E-Ticket.

Illustration

In the below example, BA (as the validating carrier) imposes to have the presence of its record locator to accept the E-Ticket transaction:

Once the TST is updated with the new itinerary and e ticket is ready for a reissue without Validating Carrier (BA) segment in the TST and PNR respectively.

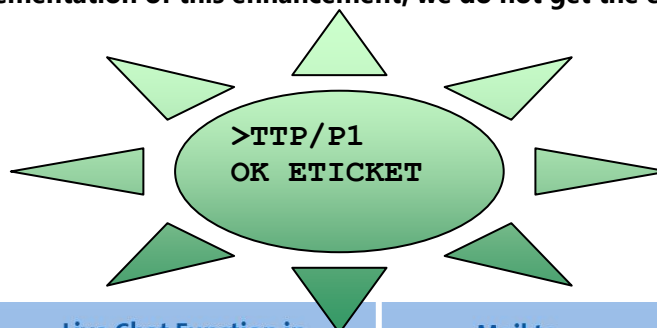

CT RJT: ETKT DISALLOWED - NEED AIRLINE R/LOC-RETRY**

Post the implementation of this enhancement, we do not get the error and E-Ticket will be reissued successfully.
