Notice from quarantine stations to persons entering Japan

- 1. If you are entering Japan and were in <u>an infected region where the new type of coronavirus is</u> <u>especially prevalent</u> within 14 days of your arrival (LEVEL3*See the table on the back of this sheet.)
- (1) Be sure to notify the quarantine officer that you came from an infected region where the virus is especially prevalent.
- (2) <u>Starting the day after you enter Japan, stand by at the specified location for 14 days</u> and behave as described in ① to ⑤ below.
- (3) You will be contacted by a public health center or other organization to follow up on your health.
- 2. If you are entering Japan from a region other than the above (LEVEL 2)

Starting the day after you enter Japan, stand by at the specified location for 14 days and behave as described in ① to ⑤ below.

- ① Do not leave the specified location for 14 days, and avoid contact with other people as much as possible.
- ② Do not use public transport.

(This includes trains, buses, taxis, airplanes on domestic lines, and other means of transport used by an unspecified large number of people.)

③ Check your health condition every day.

- Take your temperature every day to check whether you have a fever.
- Check whether you have a violent cough, difficulty breathing, or other symptoms.
- (Pay attention to the health condition of persons near you as well.)
- ④ What to do if you end up with a cough, fever, or other symptoms
 - Wear a mask and be careful not to infect other people.
 - Call the consultation center for returnees and those in close contact with the virus in advance, tell them where you stayed, and then see a doctor at the specified medical institution.
- ⑤ What to do if you live with family members, etc.
 - Please wash your hands frequently and thoroughly.
 - Make sure to get enough sleep and nutrients.
 - If someone in your family, etc. is feeling unwell, the people around the person should also wear
 masks and should limit the number of people with whom they come into contact.
