SUB: Revised conditions of acceptance to Bahrain

Please note that effective **19th December 2021**, all passengers traveling from India to Bahrain will have to produce a Machine Readable RTPCR report with valid QR Code of samples taken within 48Hrs of departure.

Also, a series of RTPCR test will continue to take place at Bahrain on Arrival, 5th and 10th day.

Non-vaccinated or passengers without a vaccination certificate approved by Govt. of Bahrain	* PCR test with QR Code - 48hrs before departure * Upon arrival, 5th & 10th day	10days Precautionary quarantine at place of residence	Passengers must provide proof of a residence either owned or leased by PAX or an immediate family member before boarding
Transit Passengers through Kingdom of Bahrain from Non-Red list countries	N/A	N/A	Must meet all requirements of final destination



Fully **vaccinated*** passengers means those who have completed 2 weeks after the last dose of vaccines.

Vaccines approved by **WHO** are Moderna, Pfizer-BioNtech, Janssen (Johnson & Johnson), Oxford – AstraZeneca, **Covishield – AstraZeneca**, Sinopharm , Sinovac & **Covaxin**

All Passengers above 06 years are required to download BeAware app and where possible complete requirements as mentioned below -

- Passengers (below 6years of age): Exempted from testing & quarantine requirements
- Passengers (6 to 12 years): Testing requirements are applicable & quarantine is exempted.
- Passengers above 12 years & fully vaccinated with approved vaccines: Testing requirements are applicable & quarantine is exempted.
- All cost associated with testing must be borne by passengers.

Please inform your passengers to download the **BeAware Bahrain** mobile application and, where possible, pay for the PCR test prior to boarding their flight to Bahrain to avoid any delays on arrival, children aged 6 years and below are exempt.
